Profile

Heraklion, The port geographically located at the northern coastal part of the island of Crete and strategically positioned among three convergent continents (Europe, Asia, Africa), holds a comparatively advantageous position and thus has been considered as one of the most important ports in Greece and in the Southeast Mediterranean.

The port is located within the old Venetian port and its invaluable cultural assets (archaeological, historical etc), is inextricably related the urban structure and landscape of the city of Heraklion, and as such, not only operates as main gateway of people and goods originated from or destined towards Crete, but also plays the role of the narrator of the local story.

Heraklion Port Authority S.A. (H.P.A. S.A.) is a publicly owned company(100% shareholder is the Hellenic Republic Asset Development Fund). superintended by the Ministry of Maritime Affairs and Insular Policy, and managed by an 11-member Board of Directors, in accordance with the provisions set forth in the regulations mandate.

The purpose of Heraklion Port Authority S.A. is the exploitation, management, operation, utilization of the port of Heraklion any area within boundaries of its terrestrial and maritime zones, in a manner that is beneficial for the public, the national and local economy as well as to the users of its services and facilities (Law 2932/01).

our The maritime zone of activity of total length of platform 3,058m and depth of vision 14.2 m, provides 5 quays for all kinds of port services, such as anchoring, passenger traffic handling, shipping and vehicle management, cultural, touristic, and fishing activities, among others. H.P.A. Furthermore, responsible for upgrading, maintaining, improving, and developing the port as well as establishing, organizing, and deploying all port facilities. Research, development and innovation programmes and projects funded by National, European, or other sources, always in accordance with the National Port Policy, implementation, also lie within the Organisation's responsibility.

Infrastructure

There are 5 quays serving the handling of bulk, dry, and general cargo, shipment containers, as well as passenger traffic generated from ferry shipping and cruises. The total length of the quays amounts to 3,058m, and the depth of the port reaches up to 14.2m.

Old Port / Marina


The old port area (Venetian Port) serves as a marina for fishing vessels and small recreational boats. There is also a significant amount of cultural heritage treasures located within the old port premises, such as the Rocca a Mare fortress dating back to the 15th century. Sailing clubs are also hosted at the old port area and support vibrant activity with their participation to international-level sailing competitions.

Ferry Shipping

The port accommodates daily passenger ship lines to Piraeus and the Dodecanese, while during the summer period there are daily routes to many islands of the Cyclades Islands complex with high- speed passenger and/or vehicle-carrying vessels, additionally available.

Cruise

The port can safely accommodate up to 5 cruise ships, in accordance with the ISPS Code. The facilities of the passenger terminal at the port can serve more than 10,000 passengers and crew members.



Cargo


The cargo facilities include both equipment (pumps or pipelines) and staff for handling general or bulk cargo and containers. Open air and covered storage units are available, and a dedicated weighbridge as well.



Moreover, at the Linoperamata coastal zone, that H.P.A. S.A, manages, and deploys as well, the total capacity for cargo containers of 27,000 cubic meters including 22 fuel tanks, via 3 distinctive anchoring where tankers are served and supplied.

Athens, December 10th, 2022 Diseminating the emblematic project "Electriport"



"ELECTRIPORT - Alternative maritime power in the Port of Heraklion"

H.P.A. S.A., highly sensitive to environmental issues and climate change, pioneers and aspir'es to become the first port in Greece to implement Cold Ironing technology systematically and comprehensively, along with renewable energy sources, implemented as Lead Partner, the project (https://electriport.eu/), funded by the EU under the European Connecting Europe Facility (CEF) mechanism.

Via the project all necessary studies were produced for Cold ironing to become a reality timely and effectively. Apart from the Technical options, studies referred to the economic and financial aspects, delivering the financial dimensions in a complete input – output CBA approach. The project has been contributing to the development of know-how, implementation of environmental policies, reduction of CO2 emissions in the port and the City of Heraklion.

The partnership covers all aspects of ELECTRIPORT, thus scientific, technical, and managerial. The results are being disseminated on local, national and EU level through globally established partnerships and established Project multipliers.


HUPPINES project (https://huppines.eu/) contributes to the increase of safe maritime access by improving basic port infrastructure, and to the increase of environmental benefits by deploying wave energy generation on the windward breakwater.


The project addresses studies for the upgrade and extension of the existing windward breakwater, and for the installation of a wave energy generation system at the port of Heraklion.

HUPPINES consists of the Detailed Engineering Design Studies for the following activities:

- 1. Upgrade of the safety level and reinforcement of the windward breakwater's effective strength.
- 2. Reinforcing the existing armouring of the breakwater, featuring a Tetrapod precast concrete block armour layer with an approximate length of 1,000 m.
- 3. Construction of new armouring to dissipate wave energy and consequently improve safety during vessel approach.
- 4. Extension of the port's windward breakwater.
- 5. Design and planning for the installation of a wave energy power station on the windward breakwater, which shall be constructed at a future stage.

Overall, the project will deliver all the necessary documentation including studies and designs, the Cost-Benefit Analysis, and the tender documents for the subsequent works, which will improve the port's safety and its environmental profile.

The northern breakwater of the port was adorned with the iconic mural "The Phaistos Disc." -2023



Solidarity- Accommodating immigrants

H.P.A. S.A. stands by the local authorities for managing impacts of the humanitarian crisis and especially the immigration influx that Greece has been meeting. In fact, the Organisation along with the local authorities, namely the Central Port Authority, the Region of Crete, the Red Cross and various voluntary organisations and communities, provides available space to host and accommodate immigrants mostly rescued at the southern part of the island. H.P.A. S.A. made all the necessary adjustments to make the former workers room ready to provide shelter, hygiene, and medical care. All necessary health tests to report the rescued people health status are being performed by specialized health personnel and the members of the "Volunteer Samaritans".

• December 2nd, 2023, 79 people rescued at the Treis Ekklisies area, were hosted by H.P.A. S.A. at the designated room

June 14th, 2023, 80 people (51 male, 17 females, 12 children) rescued at the Kaloi Limenes area, while a pregnant woman was transported to the Health

Environmental Policy Statement

Heraklion Port Authority S.A. (HPA S.A.) provides high quality and efficient port services safely while contributing to the local and national economy with sustainable development as its compass. HPA S.A manages the main link of the supply chain of Crete and the main connection of Crete to the mainland. The port of Heraklion is the main gateway for people and goods to and from the island of Crete and is considered one of the most important ports in Greece and the Mediterranean. It offers additional connection to many island regions of Greece.

Our vision is to align our operation to the principles of sustainable development, and to evolve constantly within the ever-changing International Environment. From the very beginning, we adopted the UN 2030 Agenda for Sustainable Development, akonowledling the importance of our economic, environmental and social footprint.

- to transition to the circular economy model by continuous evaluation of recycling opportunities, to reuse and minimize the waste generated within our facilities
- to better our environmental and energy footprint, and the systematic monitoring of atmospheric pollutants seawater quality and noise levels,
- · to maintain important infrastructure and to enhance it,
- to preserve and promote the historic heritage of the port for the benefit of residents and visitors of the city of Heraklion.
- · to design improved processes, facilities and activities,
- · to adapt environmental quality criteria and internationally recognized standards,
- to allocate the necessary resources and information to achieve our quality, environmental and energy objectives,
- · to comply with all regulatory and non-regulatory requirements
- to raise awareness among staff and other stakeholders and showcase our environmental performance,
- · to enhance the effectiveness of our Quality & Environment Management System.

Nothing in this Policy overrides existing Port Regulations, General Guidelines, regulations or terms and conditions.























Emissions Control

Emission control lies at the top of H.P.A. S.A. priorities. The port of Heraklion is located at the heart of the urban structure of the densely inhabited city of Heraklion. Eliminating impact (gas emissions) resulting form the port activity, is a highly important matter both for the society and the Organisation as well.

H.P.A. S.A. aims at transforming the port of Heraklion to the first Greek port to apply integrated cold ironing services (electric power provision and charging) for any type oof ported vessel, as part of the implementation and the results of the ELECTRIPORT emblematic project (Port Electrification – Alternative Maritime Power, https://electriport.eu/). The project also contributes to the improvement of the air quality and to pioneering alternative shipping.

It is estimated that CO2 emissions of the ported ships will be eliminated at above 80% until 2028.

H.P. A. S.A. performs regular air quality controls as required.

"All air quality measurements and noise levels were within permissible limits, with no readings exceeding the established thresholds."



Water Stewardship

H.P.A. S.A. deploys mechanisms that ensure water wasting is eliminated:


- Taps with new technology filters and air infusion system








Future Goals

- Maintain noise levels within limits.




